

HARDIN COUNTY BOARD OF SUPERVISORS
MINUTES – APRIL 06, 2016
WEDNESDAY – 10:00 A.M.

Chair Lance Granzow called the meeting to order. Also present were Supervisors Ronn Rickels and Reneé McClellan; and Kent Krause, Mitch Baum, Austin Kessler, Jessica Lara, Lori Kadner, Don Knoell, Jefferson Fosbender, Micah Cutler, Cindy Litwiller, Rob Maharry, and Kelly Collins.

The pledge of allegiance was recited by all in attendance.

McClellan moved, Rickels seconded to approve the agenda as posted. Motion carried.

Rickels moved, McClellan seconded to approve the minutes of March 30, 2016. Motion carried.

McClellan moved, Rickels seconded approve the April 6, 2016 claims for payment. Motion carried.

At 10:02 a.m. the Chair opened the public hearing on the Animal Feeding Operation Construction Permit, Providence 36 Site, id #68849 in Section 36 of Providence Township. Kent Krause reviewed the proposed site. With no oral or written comments or objections being received, McClellan moved, Rickels seconded to close the public hearing. Motion carried.

Rickels moved, McClellan seconded to recommend DNR approval of the Animal Feeding Operation Construction Permit for the Providence 36 Site, in Section 36 of Providence Township. Motion carried.

Rickels moved, McClellan seconded to approve the change of status for Alan Clemons, temporary/seasonal part-time, Secondary Roads/Engineer, at \$11.00/hour, effective April 6, 2016. Motion carried.

McClellan moved, Rickels seconded to approve the proposal from Rock Valley Health for wellness services to members of the Public Employee Health Plan Trust at the rate of \$120.00 per participant. Motion carried.

County Engineer Daryl Albertson provided a departmental update to the Board.

Rickels moved, McClellan seconded to approve the contract with Peterson Contractors Inc. for bridge projects BROS-CO42(80)-5F-42 in the amount \$343,082.77 and BROS-CO42(81)-5F-42 in the amount of \$416,917.23. Motion carried.

RESOLUTION # 2016-10

WHEREAS: The Hardin County Board of Supervisors is empowered under authority of the Code of Iowa to impose weight limitations on highway structures under their jurisdiction.
