Rickels moved, McClellan seconded to approve the 2015 New Business Property Tax Credit applications. Motion carried.

McClellan moved, Rickels seconded to approve the application for fireworks permit for Fogarty Farm Reunion, June 11, 2016, at 23385 115th Street, Iowa Falls. Motion carried.

Rickels moved, McClellan seconded to approve the discharge of Jennifer Raska, Sheriff's Office, effective 6-1-2016. Motion carried.

Rickels moved, McClellan seconded to approve the hiring of Karen Schucknecht, Jail Nurse, Sheriff's Office, temporary/seasonal part-time, effective 6-1-2016 at \$23.64/hour. Motion carried.

Jail Administrator, Nick Whitmore, provided an update on the Jail medical services. No action was necessary; informational only.

McClellan moved, Rickels seconded to approve the Disaster Recovery Services agreement with IP Pathways. Motion carried.

Rickels moved, McClellan seconded to approve the hiring of Jeremy Brown, temporary/seasonal part-time, Conservation Department, Calkins summer intern at \$9.00/hour, effective 5/31/2016. Motion carried.

McClellan moved, Rickels seconded to approve the annual agreement with "Solutions" Inc. for FY 2016/2017. Motion carried.

Rickels moved, McClellan seconded to approve the Recorder's monthly report for May 2016. Motion carried.

McClellan moved, Rickels seconded to approve the hiring of Angela Silvey, full-time Office Manager, Secondary Roads Department, effective 6/6/2016 at \$17.50/hour. Motion carried.

McClellan moved, Rickels seconded to approve the change of status for Michael Mosch to truck driver status, Secondary Roads Department, full-time, effective 6/6/2016 at \$20.05/hour. Motion carried.

Utility Permits:

Rickels moved, McClellan seconded to approve the utility permit application by Midland Power Cooperative for the purpose of expending overhead line in Section 20, Pleasant Township on the South side of P Avenue. Motion carried.

Rickels moved, McClellan seconded to approve the utility permit application by Heart of Iowa for the purpose of installing fiber optic line to a new house at 34175 315th Street. Motion carried.

Rickels moved, McClellan seconded to approve the utility permit application by Heart of Iowa for the purpose of rerouting fiber and copper cable due to bridge replacement south of Steamboat Rock on S56. Motion carried.

Rickels moved, McClellan seconded to approve the utility permit application by Hubbard Cooperative Telephone for the purpose of installing new fiber optic cable to upgrade from old copper cable near Hubbard. Motion carried.

Rickels moved, McClellan seconded to approve the utility permit application by Windstream Iowa Communications for the purpose of boring under Elk Creek and rerouting fiber optic cable due to bridge replacement south of Steamboat Rock on S56. Motion carried.

Rickels moved, McClellan seconded to approve the Iowa DOT application and utility agreement by Heart of Iowa for the purpose of installing fiber optic cable in state highway right-of-way along Highways 65 and 175 east and west of Eldora, and for boring under various county roads along proposed route. Motion carried.

Rickels moved, McClellan seconded to approve the Iowa DOT application and utility agreement by Hubbard Telephone Cooperative for the purpose of installing fiber optic cable in state highway right-of-way along Highways 65 and 175 from 1.56 miles north of the Hardin/Story line and running north to 220th Street, and for boring under various county roads along proposed route. Motion carried.

Secondary Roads Department:

IRVM Manager, Cory Engle, updated the Board on applying for an IRVM grant. No action was necessary; informational only.

Other Business:

Community Services Director, Linn Adams, updated the Board regarding the end of the fiscal year funds transfer to the Region. No action was needed at this time; informational only.
