The Hardin County Board of Supervisors held their regular meeting at 9:00 AM on August 07, 2024, at the Hardin County Courthouse large conference room in Eldora, Iowa.

RESOLUTION NO. 2024-26
TO RENEW 28E AGREEMENT WITH NORTHEAST IOWA REGIONAL GROUP

WHEREAS, Hardin County is currently in a 28E Agreement with Northeast Iowa Regional Group for assistance with hazardous material emergencies; and
WHEREAS, the aforementioned 28E Agreement will end in September 2024 unless extended or renewed by Hardin County; and
WHEREAS, Iowa Code 28E.4 requires that a 28E agreement be authorized by resolution or ordinance,
NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Hardin County, Iowa, hereby renew the 28E Agreement with NIRG, and further authorize and direct the Chair of the Board of Supervisor to execute said agreement and take any further action required to effect said agreement.
