The Hardin County Board of Supervisors held their regular meeting at 9:00 AM on October 02, 2024, at the Hardin County Courthouse large conference room in Eldora, Iowa.

McClellan moved and Granzow seconded to approve the agenda. All Ayes. Motion carried.

Hoffman moved and McClellan seconded to approve the minutes of October 02, 2024. All Ayes. Motion carried.

McClellan moved and Hoffman seconded the motion to approve claims for payment for October 09, 2024. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to approve Resolution 2024-35 Establishing Speed limit on County Highway D65 Between H Ave and U.S. Highway 65 Located in Hardin, County, Iowa. Roll Call was taken. Roll Call Vote: "Ayes" Granzow, Hoffman, and McClellan. "Nays" None. Motion carried. Resolution No. 2024-35 is hereby adopted as follows:

Resolution 2024-35

Establishing Speed Limit on County Highway D65 Between
H Avenue and U.S. Highway 65 Located in Hardin County, Iowa

WHEREAS, The Board of Supervisors is empowered under authority of Sections 321.255 and 321.285 subsection 5b of the Code of Iowa, to determine upon the basis of an engineering and traffic investigation that the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

WHEREAS, such investigation has been completed by the Hardin County Engineer's Department.

NOW, THEREFORE, BE IT RESOLVED by the Hardin County Board of Supervisors that speed limit be established, and appropriate signs erected at the locations described as follows:

On County Highway D65, between H Avenue and U.S. Highway 65 located in Hardin County, Iowa; East & West Bound Traffic

1. 45 MPH from a point 200 feet west of the Southbound I Avenue Intersection, thence east 1/10th mile to a point 200 feet east of the Northbound I Avenue Intersection.

This Resolution shall be in effect when the signs have been erected and shall be in effect for an indefinite amount of time, pending the rehabilitation of the roadway. Passed and approved this 9th day of October 2024.

McClellan moved and Hoffman seconded the motion to approve Utility Permit UT-24-026 for Iowa Regional Utilities Association. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to approve waiving delinquent property tax interest on parcel number 892113408005. All Nays. Motion failed.

Hoffman moved and McClellan seconded the motion to approve to give relief to the tax certificate purchaser and have the county Treasurer inform them that the sale for that certificate will be voided and to waive the delinquent interest for the new owner of parcel number 892113408005. All Ayes. Motion carried.

McClellan moved and Hoffman seconded the motion to acknowledge the Treasurer's Semi-Annual Report for FY 23/24. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to acknowledge the Recorder's Report for September. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to acknowledge the Auditor's Report for September. All Ayes. Motion carried.

McClellan moved and Hoffman seconded the motion to approve the change of status in the Sheriff's Department for the resignation of Colin Chinery as a full-time Communications Operator, at an hourly rate of \$23.03, effective September 25, 2024. All Ayes. Motion carried.


